Election of Officers

Ms. Hollingsworth opened the floor for nominations of officers. Board member Steve Corona nominated Julie Hollingsworth for President, seconded by Glenna Jehl; Julie Hollingsworth nominated Steve Corona for Vice President, seconded by Maria Norman; Julie Hollingsworth nominated Anne Duff for Secretary, seconded by Maria Norman. Officers for the 2018 Board of School Trustees: Julie Hollingsworth, President; Steve Corona, Vice President; and Ann Duff, Secretary.

Consent Agenda

Dr. Robinson presented the following consent agenda items with recommendations for approval: Appointment of Treasurer and Deputy Treasurers; Minutes from the regular Board meeting, December 11, 2017 and special Board meeting held December 18, 2017; Vouchers for the period ending December 25, 2017, payroll for the periods ending November 24 and December 8, 2017; and the Personnel Report.

Appointment of Treasurer and Deputy Treasurers

**RECOMMENDATION:** It is recommended that Sherry L. Nidlinger be appointed as treasurer and Stefan W. Pittenger and Alicia M. Stapleton as deputy treasurers for calendar year 2018, and that bonds for these positions be set as follows:

Treasurer	\$200,000
Deputy Treasurers	\$50,000

It is further recommended that the administration be granted authority to execute any corporate resolutions required by the various banking depositories.

**RELATED INFORMATION:** IC 20-26-4-1 provides for appointment of a treasurer and deputy treasurers at the same time that the new Board organizes.

Having two deputy treasurers better ensures timely deposits, investments, and continuity in money management affairs. Ms. Nidlinger serves as the full-time treasurer for the corporation while Mr. Pittenger and Ms. Stapleton serve the district as director of fiscal affairs and deputy treasurer, respectively.

IC 20-26-4-5 provides that the treasurer and deputy treasurers give a bond for the faithful performance of duty in an amount determined by the governing body.

**Minutes** The Minutes from the regular Board meeting held December 11, 2017 and the special Board meeting held December 18, 2017 were distributed to Board members for review with a recommendation for approval.

**Vouchers and Payroll** **RECOMMENDATION:** It is recommended that the Board approve the vouchers for the periods ending December 25, 2017 and the payroll for the periods ending November 24 and December 8, 2017.

**RELATED INFORMATION:** All vouchers paid by the Fort Wayne Community Schools appear on the December 25, 2017 voucher listing totaling \$5,032,057.87.

Discovery Education Contract

Dr. Robinson presented the following recommendation concerning the Discovery Education Contract:

**RECOMMENDATION:** It is recommended that the Board approve a four-year contract with *Discovery Education* in the amount of \$1,620,000 for professional learning services and the development of STEM/STEAM curriculum and framework for the following schools:

- STEM: Irwin (approved on 8/14/17), Portage, Wayne
- STEAM: Whitney Young, Weisser Park, Memorial Park, South Side

**RELATED INFORMATION:** The Board approved the *Discovery Education* contract for Irwin (8/14/17) as the initial step in this partnership. The inclusion of the additional schools will solidify the K12 pathways for STEM and STEAM in two feeder areas. *Discovery Education* will provide professional learning, educational resources and digital content related to Science, Technology, Engineering and Math (STEM). The four-year contract will include:

- Year 1: Visioning and building the foundations for STEM/STEAM
- Year 2: Building a Foundation for Project-Based Learning
- Year 3: Transdisciplinary Teaching for vertical articulation among all grade levels and integrative instruction across content areas.
- Year 4: Developing Sustainability with Transdisciplinary Units and STEM/STEAM Practices.

This program supports FWCS District Goal 1: Achieve and Maintain Academic Excellence and Goal 2: Engage Parents and the Community.

Superintendent Robinson spoke of the committee she will be serving on, along with other superintendents, at the request of the State Board of Education. The first meeting is tomorrow (1/9) and the intent of this committee is to work through the details of the Graduation Pathways that was recently passed by the SBOE. Also connected is a proposal for changes to the A-F procedure which was developed without any input from school based individuals or the DOE, as well as suggested changes in diplomas.

Julie Hollingsworth said she is happy that Superintendent Robinson and other area superintendents have been asked to sit on this SBOE committee.
