## Pre-K Curriculum Adoption

Dr. Robinson presented the following recommendation concerning the Pre-K Curriculum Adoption:

**RECOMMENDATION:** It is recommended that the Board adopt Creative Curriculum for Preschool Students, Creative Curriculum for Toddlers and Twos (Functional Skills Preschool) and Teaching Strategies GOLD Assessment Tool for 2019-2025 use in all Pre-K classrooms in Fort Wayne Community Schools. The total cost is \$219,856.22: contract - \$182,499.22; professional learning - \$18,143.00; and Teaching Strategies GOLD Assessment Tool - \$19,214.00.

**RELATED INFORMATION:** A Pre-K Curriculum Team consisting of FWCS curriculum coordinators, special education administrators, building level administrators, and Pre-K teachers examined curriculum materials for Pre-K classrooms. The Curriculum Department researched, reviewed and vetted curricular options for the 2019-2025 school years. Administrators visited early childhood centers around the state to observe Creative Curriculum being implemented. Teacher teams piloted the curriculum materials and provided feedback that was used to support the recommendation of textbooks and related materials for adoption.

The FWCS textbook adoption process addresses District Goal I: *Achieve and Maintain Academic Excellence*.

Questions were answered by Jennifer Mable, Director of Curriculum, Assessment, and Instruction, Katie Ziegler, Pre-K Coordinator.

A motion was made by Anne Duff, seconded by Tom Smith, that the recommendation concerning the Pre-K Curriculum Adoption be approved. Roll Call: Ayes, unanimous; nays, none.

Application for Common School Fund Loan Dr. Robinson presented the following recommendation concerning the Application for Common School Fund Loan:

**RECOMMENDATION:** It is recommended that the Board approve the application for and acceptance of an advancement from the Indiana Common School Fund (CSF) for educational technology equipment in the amount of \$2,000,000.

**RELATED INFORMATION:** Advancements from the Common School Fund provide funds for school districts to purchase educational technology. The Fort Wayne Community Schools (FWCS) will use these moneys to help fund the FWCS technology plan previously submitted to the State. Technology funds are currently insufficient to fund all the technology needs of the school corporation.

Funds are provided as a loan and are awarded to school corporations on the basis of assessed value (AV) per pupil, with low AV per pupil corporations receiving funds before high AV per pupil corporations. FWCS therefore cannot be assured of receiving the requested advancement.

Should the application be successful, funds will be budgeted in the Debt Service Fund to repay this loan beginning in the year 2021. Interest on the loan is expected to be no more than four percent and is likely to be as low as one percent.

Common School Fund advancements differ from School Technology Advancement Account (STAA) loans, which FWCS receives on an annual basis. Unlike CSF advancements, STAA advancements are given to all applying school corporations, regardless of their assessed value per pupil ranking.

Questions will be addressed by Director of Technology Jack Byrd.

Board Member Anne Duff visited Adams Elementary this week as a mystery reader. She enjoyed reading to, and interacting with, the students.

Board Member Jordan Lebamoff applauded the new landscaping at South Side High School.

Superintendent Robinson mentioned that the school year was almost over and she thanked the Board for another great year and for the support they give to the people who work in the District. Dr. Robinson also thanked the parents for allowing FWCS to be with their children.

Board President Julie Hollingsworth thanked all the teachers and knows they too look forward to the end of the school year. Ms. Hollingsworth also spoke of a recent Letter to the Editor from Donna Kizer and encouraged others to voice their support of public education. Lastly Ms. Hollingsworth spoke of a visit to North Side High School to see the presentations of seniors in a dual credit English class. The students did a fantastic job. The skills used for the presentations – public speaking, researching, writing – are not items that are tested on a standardized test, but they are certainly skills that serve students for the rest of their lives and that employers are looking for.
