Riley Hospital                **RECOMMENDATION:** It is recommended that the Board recognize Fort Wayne Community Schools for Children and the organizers for the Riley Hospital Kids Caring & Sharing Campaign for becoming a Red Wagon Corporation

**RELATED INFORMATION:** Fort Wayne Community Schools achieved Riley Hospital Red Wagon Corporation status (formerly known as Miracle Corporation status) for the first time in 2018. To reach this level, each school in the district participated in the campaign for Riley Hospital for Children and raised at least \$1 per student through the Kids Caring & Sharing school philanthropy program. Harris Elementary School Principal Jana Ankenbruck and Secretary Carol Grable organized and led the campaign. Thousands of children, including those from Fort Wayne Community Schools, have benefited from the medical care that Riley provides. This is a testament to the District's generosity and support of children.
