Purchase of Lenovo Laptops Dr. Robinson presented the following recommendation concerning the Purchase of Lenovo Laptops:
RECOMMENDATION: It is recommended that the Board approve the purchase of 3,474 Lenovo ThinkPad Yoga 11e laptop computers from ProSys of Indianapolis for \$1,556,004.
RELATED INFORMATION: These laptops are for student use at various schools at each level and will expand the capability for teachers to support instruction and enhance the learning environment through technology integration. This purchase is part of a 5-year plan that aims to provide equitable technology access to all students and better prepare our students for college and their career.
 FWCS was able to secure pricing that was below General Services Administration (GSA) pricing. Indiana law does not require public bidding for purchases made at or below GSA pricing.
 Funding will come from the Common School Fund.
 Questions will be addressed by Jack Byrd, Director of Technology.

Application for Common School Fund Loan Dr. Robinson presented the following recommendation concerning the Application for Common School Fund Loan:
RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of an advancement from the Indiana Common School Fund (CSF) for educational technology equipment in the amount of \$1,950,000.
RELATED INFORMATION: Advancements from the Common School Fund provide funds for school districts to purchase educational technology. The Fort Wayne Community Schools (FWCS) will

use these moneys to help fund the FWCS technology plan previously submitted to the State. Technology funds are currently insufficient to fund all the technology needs of the school corporation.

Funds are provided as a loan and are awarded to school corporations on the basis of assessed value (AV) per pupil, with low AV per pupil corporations receiving funds before high AV per pupil corporations. FWCS therefore cannot be assured of receiving the requested advancement.

Should the application be successful, funds will be budgeted in the Debt Service Fund to repay this loan beginning in the year 2019. Interest on the loan is expected to be no more than four percent and is likely to be as low as one percent.

Common School Fund advancements differ from School Technology Advancement Account (STAA) loans, which FWCS receives on an annual basis. Unlike CSF advancements, STAA advancements are given to all applying school corporations, regardless of their assessed value per pupil ranking.

Second Semester 2016-17 Extracurricular Account Reports

RECOMMENDATION: It is recommended that the Board accept the Extracurricular Account Reports for the second semester of the 2016-17 school year.

RELATED INFORMATION: Indiana Code 20-41-1-8 requires an accurate account of all money received and expended by extracurricular accounts. A report of the sources of all receipts, the purposes for which the money was expended and the balance on hand is required to be filed with the School Board of Trustees. All extracurricular semester reports were audited by the Business Office. The General Ledger summary report of each school's accounts is provided. All extracurricular records are maintained for five years and are available for inspection.

A copy of the Extracurricular Account Reports is on file in the Superintendent's office.

2018 Budget Report

Chief Financial Officer Kathy Friend presented a report that describes the year 2018 budgets for the General Fund and the eight tax supported funds: Racial Balance, Capital Projects, Transportation, Bus Replacement, Debt Service, Referendum Debt, Pension Bond and Museum of Art. The public budget hearings will be held on October 9, 2017. Board action is scheduled for these budgets on October 23, 2017.

Comments

Board Member Steve Corona shared that more than 150 young Latino men, most of them FWCS students, attended a fair at Ivy Tech to explore careers. Mr. Corona thanked Martin Murphy and Shenita Piper of the College and Career Readiness Department as well as school counselors for helping students. Mr. Corona also commented that he will be attending the National School Boards Association Council on Urban Education Conference this week and will participate in a panel discussion on the state of urban schools. He will share his experience with the Board members.

Board Member Jordan Lebamoff commented that he is tired of the divisiveness of the Nation and thinks we should take the lead from kids – they are doing it right.

Dr. Robinson commented that today had been an exciting day. She attended the Little Kids Rock event at St. Joe Central Elementary with Mr. Chuck Surack, who has donated musical instruments. FWCS has strong community partners.

Board President Julie Hollingsworth thanked Jordan for his comments and she thinks we have a stronger community when we have shared experiences and values and great public schools. We need to learn to understand each other, not only as part of a group but as individuals. Ms. Hollingsworth also commented on the news that universities are offering free courses for teachers wanting to get certification in teaching dual credit classes. Data shows that graduation rates are significantly better for students who take dual credit courses.
